PURPOSE

The Leadership Manatee program is designed to expose current and future leaders to major aspects of Manatee County, foster an understanding of the opportunities and challenges we face, and build a network of connected, committed leaders in our region. The program's purpose is:

- To identify community leaders of diverse backgrounds.
- To develop their potential and desire to accept civic responsibilities and leadership roles.
- To expose community leaders to the problems and opportunities that face Manatee County.
- To build a realistic understanding of leadership in today's complex society.
- To open a dialogue among emerging and current community leaders.
- To acquaint leaders with the processes, programs, opportunities, and challenges for individual involvement in Manatee County.

SELECTION CRITERIA

The most important factor in participant selection is identifying those individuals who are most apt to use their leadership knowledge and skills for the long-term benefit of this community.

Based upon this criteria, individuals selected will:

1. Have demonstrated commitment through past and current community engagement.
2. Have attained a leadership position within their business or organization or have the potential for advancement to top leadership positions.
3. Have a sincere commitment, motivation, and interest in serving their community.
4. Be interested in, or intend to seek, leadership roles in the community.
5. Represent a cross section of the business community of all ages and geographic representation, including government representatives, professional leaders, and community service volunteers. Because diversity is an important component of the program's purpose, it is not unusual for a participant to apply more than once before they are accepted.

The selection committee is comprised of three Manatee Chamber of Commerce representatives, three Bradenton Kiwanis representatives, one representative from each of the past three year's Leadership Manatee classes and the Manatee Chamber of Commerce president or his/her designee.

GRADUATION & ATTENDANCE REQUIREMENTS

One absolute requirement of participation in Leadership Manatee is attendance for the entire Orientation and Simulated Society sessions on August 26 and 27, 2024. Additionally, each class member will serve as a facilitator for one day of the next year's Leadership Manatee program and one day of the Junior Leadership Manatee program. So that participants can gain full benefit from the Leadership Manatee program, graduation from the program is based upon meeting attendance requirements. The equivalent of more than two (2) days of absences prohibits graduation at the end of the session year. No tuition refunds will be granted due to excessive absences nor leaving the program at any point after accepting a position in the class. If a day includes a bus tour, class members are required to ride the bus during the entire session.

TUITION

Tuition covers the cost of all session materials, field trips, refreshments, meals, transportation and the graduation ceremony. Funds are available, on a limited basis, for qualified scholarship applicants.

2024-2025 COURSE OUTLINE

Schedule is subject to change.

Sessions typically begin at approximately 7:15 a.m. and end at approximately 5:30 p.m.

Monday, August 26 - Afternoon & Tuesday, August 27 - Day & Evening

ORIENTATION & SIMULATED SOCIETY PROGRAM - The simulated community game develops interpersonal communications and explores diversities in socioeconomic structure through role playing situations which test personality and leadership skills in confrontational situations. Attendance is mandatory for entire course of both Simulated Society sessions. A dinner with the Board of Governors is held on Tuesday evening for class members and their guests.

Wednesday, September 11

COMMUNICATIONS & CULTURE - Half of this session looks at the communications media located in the area and the role they play in commerce and quality of life. The second half reviews area cultural opportunities and explores Manatee's vision for cultural activities and the arts.

Wednesday, September 25

EDUCATION - A look at the structure and operation of our public, charter, and private educational systems K-12 and post-secondary. Includes discussion and interaction relating to education's role in our economic prosperity. This class requires independent attendance at a Manatee School Board meeting prior to the session.

Wednesday, October 9

HEALTH CARE - An overview of medical care in Manatee County including tours of hospitals, clinics, and special care facilities. Discussions will focus on the current health care issues facing our community.

Wednesday, October 23

LOCAL GOVERNMENT - An overview of the structure and function of our local government along with discussion of government's role in addressing local challenges. This class requires independent attendance at a city or county government meeting prior to the session.

Wednesday, November 6

ESCAPE TO REALITY - Leadership and team-building initiatives involving preparation, problem solving, trust and cooperation. Includes discussion relating to personal discoveries through the initiatives. A challenging and fun way to learn more about yourself.

Wednesday, November 20

AGRICULTURE - Discover agricultural resources as a key component of the economy and history of Manatee County.

Wednesday, December 4

STRENGTHSFINDER - Fast-paced, high-energy exploration of leadership traits and what you do best. Helps leaders develop their greatest talents into strengths. Requires completion of an online strengths assessment prior to the session.

Wednesday, January 8, 2025

LAW ENFORCEMENT - A look at our law enforcement agencies and how they interact. Includes tours of the County jail systems. This requires a minimum three (3) hours of observation with the Sheriff's Department or other law enforcement agency prior to the session. This involves riding with police patrol and observing various aspects of law enforcement.

Wednesday, January 22

BUSINESS/INDUSTRY - A look at the diversity of the local business economy including a statistical overview of the county. Includes tours of several area businesses and industries.

Wednesday, February 5

LAND USE/TRANSPORTATION - An in-depth look at growth guidance and the tools that control land use decisions as well as developing a deeper understanding of infrastructure, including transportation.

Wednesday, February 19

HUMAN NEEDS - Exposure to some of the programs and facilities in Manatee County that work to meet the challenges facing our community, particularly by our non-profit service providers.

Wednesday, March 5 - Evening

GRADUATION - A special dinner event honoring those who have completed the Leadership Manatee Program.
